Report to the Citizens of Laflin

I have been a resident of Laflin since 1967 and your Mayor for the past ten years. I was a founding member of the Laflin Library which was established in 1972. This is the jewel of our community and is a state-of-the-art library. We are the only Borough, with a population under 2,000, to have such a library. To establish the Dewey Decimal System in our Library, we petitioned the Wilkes-Barre Council to provide CETA workers. The accounting was done, pro-bono. The incorporation was also done pro-bono, both by husbands of the original women whose dream was realized when the Borough Council in 1999 moved the library into its present quarters. The library will celebrate its 45th Anniversary in September, 2017 and all our citizens are invited to the celebration. ... Continued on Page 2

During my tenure as Mayor, I have worked with three different Councils. I would like to thank the present council for its continuing respect for me and for all members of our community. Its members have worked long and hard to provide our Borough with a safe place to live and raise their families. For the first time, a member of Council has donated her entire salary to our library. Our Council President, who has a long history of service to our community, is always available to answer citizen's questions.

As you have read, the State Police are planning to charge every community for their services. They need to do this since they have not been able to hire enough officers to fill their vacancies. Our State Police Representative, Trooper Deanne Piekanski, keeps us informed of any State Police activity in our areas. She indicated that while for several years the State Police were understaffed, this is now a major concern. While the original amount considered is \$25.00 per person, as stated in our newspapers, the actual cost exceeds \$200.00 per person.

The answer is, of course, regionalization. Our State Representative Michael Carroll endorses this concept and grants to get started are available. A meeting was held in our Borough to discuss this plan and was attended by representatives from Jenkins, Dupont, Pittston Township, and Laflin. Among the things discussed was the need in Laflin for policing of Laflin Road where overweight trucks continue to be a problem. While we had a Police Department, our income from these patrols was substantial. The Northeast Regional Police Force will be staffed by permanent officers. If you have a problem, their response time will be generally five minutes. While our State Police do their best with their small staffs, their response time to problems is often over one-half hour.

We will honor all our veterans with a Ceremony on Memorial Day at the Creekside Memorial Playground at ll:00am. This Memorial Day ceremony is dedicated to all who served for the glory of God and country from Laflin Borough. If you are a veteran, and do not know if we have your name, please check with our Borough Manager, Chuck Boyd. Save the date, May 29, 2017, and plan to join your neighbors.

My seventeen- year old granddaughter, who lives in Laflin, is in Peru as a Rotary Exchange Student. She has been there since July and will be back in June. She tells me how this experience has increased her love for her country. She sent me this quotation: "Kind Words Will Unlock an Iron Door-A Turkish Proverb". My hope is that you will continue to have "kind words" for each other.

MS4 Stormwater Regionalization

Increasing Regulatory Requirements

As the result of The Chesapeake Bay Agreement of 1983, The United States Environmental Protection Agency (EPA) has mandated the governance of stormwater and reduction of pollutants entering the Chesapeake Bay. The Pennsylvania Department of Environmental Protection (DEP) ensures affected municipalities satisfy these mandates through the imposition of Municipal Separate Storm Sewer (MS4) permits, first issued in 2003. New requirements of the 2018 MS4 Permit include the following:

- 1. Implementation of Best Management Practices (BMPs) by 2023 to reduce sediment pollution from each municipality by 10%, phosphorus by 5% and nitrogen by 3%.
- 2. Implementation of BMP's by 2023 to reduce pollution in the drainage area of impaired waterways in each municipality.
- 3. Complete Chesapeake Bay Pollution Reduction Planning and impaired water pollution reduction planning by September 2017.
- 4. Complete mapping of stormwater infrastructure for use in developing PRPs.
- 5. Complete Pollution Control Measure (PCM) mapping and analysis (related to acid mine drainage and pri ority organic compounds.)
- 6. Develop adequate staffing and funding to complete the above items while continuing to implement the six Minimum Control Measures, and submit annual Status Update Reports.

MS4 permits are renewed in five year cycles. It is assumed that requirements of the permit will continue to increase in future years and will be supported via WVSA. Current permit requirements are an unfunded mandate which would place a significant strain on municipal budgets.

Benefits of Regionalization

Regional stormwater management enables watershed based planning and implementation; a more holistic solution to stormwater management problems at a fraction of the cost.

- Under a "per municipal" approach to MS4 permit compliance, each municipality would bear the cost of developing their own pollution reduction plans and siting BMPs within their municipality, and within the drainage area of impaired waterways, in order to ensure the required pollutant load reductions (10% sediment, 5% phosphorus and 3% nitrogen) are met.
- Under a regional approach in Wyoming Valley, DEP will accept a single Chesapeake Bay pollution reduction plan for all 36 municipalities and six watershed based plans for the Region.

If a municipality were to complete Pollution Reduction Planning and implementation on their own, they are limited to the available land in their municipality and, in many cases, in the drainage area of an impaired stream. A regional plan provides significant flexibility in that the BMPs may be located anywhere within the watershed. This provides the opportunity to site and select BMP's in ways which provide the greatest pollutant reduction for the lowest cost. In the case of the Wyoming Valley Region, regional Pollution Reduction Planning results in a reduced number of required BMP's for permit compliance which cuts the average cost per municipality by more than half.

The region will experience additional savings as economies of scale are realized in tackling MCM's, and fixed administrative costs are spread over a larger number of property owners. In future years, a regional approach to existing infrastructure operation, maintenance and improvements will yield even more cost savings.

Road Milling and Paving Work Scheduled in the Borough

Road paving work will commence in the borough, weather permitting, this month. The following roads are scheduled for paving starting the week of May 15th and will be funded by way of casino grant funds awarded to the borough by the Dept. of Community & Economic Development (DCED). The award was for \$125,000.00.

Laurelwood Drive 🔶 Redwood Drive 🔶 Oakhill Drive 🔶 E. Ashwood Drive

The second phase of milling and paving will be completed this June by a separate paving contractor. The roads in the second phase:

Cedarwood Drive ♦ Sprucewood Drive ♦ Lower Haverford Drive

During the milling phase base repairs will be completed and stormwater catch basins will be adjusted. Asphalt curbing will be installed to complete the work. This work schedule is weather sensitive and could change.

Access to your driveways, although limited, will be available during this process. No vehicle will be allowed to be parked on the street while this work is being done and vehicles should be off the street by 7:00am. We apologize in advance for any inconvenience this project may cause and thank you for your continued cooperation and support in making Laflin a better place.
