# **MEETING MINUTES**

## **Unfinished Business:**

A) Reject All Prior Paving Project Bids for 2019 -

Mr. Benderavich asked for a motion to reject all prior bids for Manchester and Oakwood/Fordham.

B) Laflin Borough 2019 Paving Project -

Project Selection & Advertisement / New Specifications to Rebid

Mr. Benderavich asked councilmembers' opinion on which paving project should be considered this year. It was noted Oakwood Drive has significant stormwater work that needs to be completed with the paving work. Councilman Yastremski indicated he would be in favor of going with Manchester Drive. Manchester Drive is less expensive and can be done with replacing the concrete gutters with asphalt and asphalt curbs.

Councilwoman Natt asked if the project would be completed with General Fund money and if there is enough to cover the cost. Mr. Benderavich responded in the affirmative for both questions indicating a conservative number of approximately \$180,000.00 buffer. Councilwoman Natt agreed that Manchester Drive would be a good project if the funding is available.

It was clarified that the vote would be to advertise and put the road project out to rebid and not approve the work to be done. Grants will still be submitted for paving work as is normally done.

Mr. Benderavich asked for a motion to advertise for rebids on Manchester Drive paving with the new specification of eliminating the concrete gutters and replacing with 4" machine laid asphalt curbing. Maplewood Drive would be included as an add-alternate option.

The borough needs the property to proceed with the salt shed grant and Mr. Benderavich believes the entire 1-acre parcel is needed and not just part of the property that

Vincent Kasa is proposing to sell. Mr. Benderavich recommended a \$10,000.00 offer for the full 1-acre tract of land based on the report received the day of the meeting.

Some discussions followed on subdivision cost and time, extra room the borough would have in the future and the value of the land.
