It was announced that the borough building lighting upgrades were completed and the exterior of the building is much brighter.

Mr. Boyd discussed an issue recently brought to his attention concerning the handling of feral cats delivered to the SPCA for removal under the municipality agreement with the shelter. The SPCA possibly could be returning all feral cats to the borough colonies after they are fixed and given a rabies shot by Brenda Buckler of Whisker's World. This is against the municipality agreement and only the feral cats trapped under the TNR program should be fixed and returned to the borough. Mr. Benderavich advised Solicitor Sanguedolce to draft and send a letter to Todd Hevner, SPCA Director clarifying the borough's position. The borough still has ten No Nonsense Neutering coupons to be used for the TNR program.

<u>Anthony Menendez, 4 Walnutwood Drive</u> – came to the meeting again to request that Council consider selling additional land to the homeowners on Walnutwood Drive behind their existing homes. He came to get updates on the status of the property transfer. Mr. Benderavich responded to say nothing can be decided until the title search is completed, and the land is bought by the borough. Nothing can be done until the land is in the borough possession.

The other issue Mr. Menendez wanted to ask about is the rumor that a gas main line will be installed in the back of his property. Mr. Benderavich confirmed that Williams Gas Pipeline is proposing another line. Mr. Benderavich further communicated the discussions he and Mr. Boyd had with the gas company.

Discussions continued on the location of the proposed line, the problems with fitting the new line in the existing gas right-of-way, and the possibility of a walking track being installed.

<u>Tyler Salerno</u>, <u>Assured Partners of Northeast PA</u> – arrived later in the meeting and answered a question from Councilman D'Eliseo on the umbrella insurance limits. He will provide estimates on increasing the limits for the next council meeting.
